Specificity: Recognizes a glycoprotein of 110kDa, which is identified as CD68.

Background: It is important for identifying macrophages in tissue sections. It stains macrophages in a wide

variety of human tissues, including Kupffer cells and macrophages in the red pulp of the spleen,

in lamina propria of the gut, in lung alveoli, and in bone marrow. It reacts with myeloid precursors and peripheral blood granulocytes. It also reacts with plasmacytoid T cells, which are supposed to be of monocyte/macrophage origin. It shows strong granular cytoplasmic staining of chronic and acute myeloid leukemia and also reacts with rare cases of true

histiocyticneoplasia. Lymphomas are negative or show few granules.

Positive Control: lymph node or spleen., Tonsil, U87MG cells

Cellular Localization: Cell membrane, Endosome membrane, Lysosome membrane



Formalin-fixed, paraffin-embedded human Histiocytoma stained with CD68 Mouse Monoclonal Antibody (C68/684).

Procedure:

- 1. Tissue Section Pretreatment (Highly Recommended): Staining of formalin fixed, paraffin embedded tissue sections is significantly enhanced by pretreatment with Tris-EDTA HIER Solution (10x) pH 9.0 (ScyTek catalog# TES500) or Citrate Plus (10x) HIER Solution (ScyTek catalog# CPL500).
- 2. Primary Antibody Incubation Time: We suggest an incubation period of 30 minutes at room temperature. However, depending upon the fixation conditions and the staining system employed, optimal incubation should be determined by the user.
- 3. Visualization: For maximum staining intensity we recommend the "UltraTek HRP Anti-Polyvalent Lab Pack" (ScyTek catalog# UHP125, see IFU for instructions) combined with the "DAB Chromogen/Substrate Bulk Pack (High Contrast)" (ScyTek catalog# ACV500, see IFU for instructions).

Precautions: Contains Sodium Azide as a preservative (0.09% w/v).

Do not pipette by mouth.

Avoid contact of reagents and specimens with skin and mucous membranes.

Avoid microbial contamination of reagents or increased nonspecific staining may occur.
